 - 1. I'm emailing in regard to Dave Bergdorf's 65 acre sale i Section 35. There seems to be some confusion as to the requirements of the sale. It appears that the Town would like to see a Certified Survey Map to complete the new acquisition. This would be a Minor Land Division by State Statutes, but in this instance it should not be a requirement. State Statutes require CSM's for less than 1 ½ acre parcels. Also Town Ordinance does not require a CSM for parcels over 10 acres (please see attachment), only review. The Town has reviewed the proposed division and as such its approval is admitted into the minutes of the Town meeting creating public record. Because of this there is no need for the Town to actually "sign off" on the actual map itself as it is not a CSM. Once approved and in the minutes, Dave only needs to have a legal description drafted (this was on the Exhibit) and included on the deed required to transfer the property. Hopefully, the Exhibit will also be included with said deed. Once his attorney or Title Company has drafted the correct document, all that remains is for that document to be recorded with the Washington County Register of Deeds to create the transfer again, as the transfer would be exempt for the Certified Survey Map requirement.
