    - i. New ordinance to work in the Right of Way. A permit is required. Section 2.08
    - ii. Driveways Culverts on town roads shall be installed according to the approved Town Driveway permit. No concrete surface shall be allowed in the highway right of way on Town roads except where a concrete curb has been installed as part of the roadway. Section 5.06
    - iii. Recreational Vehicles The use of a travel trailer or motorhome on vacant parcels is limited to recreation only. Section 5.05
    - iv. Adoption of residential and commercial building codes. New ordinance 2023-01
- 6. Old Business
  - a. McClain, Brent (5310 Sunset) Build outbuilding in front of an existing outbuilding which is in front of the house CUP
    - i. Review and recommendation.- **Motion**(Ellenbecker/Etta) to recommend to the Board that the CUP be approved. Motion carried.

  - a. Canter, Chris (W5591 St Killian Dr) Division of land and/or clubhouse
