 - iii. 3.08 D Max Density for traditional should be 1 unit/2 acres.

 - Long driveways Should we have wordage that the driveway should be wider every 400 ft for emergency vehicle traffic. Schulz will look at the Town of Kewaskum for wordage.
 - Dog limits Change so parcels read accessory use is 3 dogs, Conditional use for more than 3. Take off the minimum acreage verbage. This does not apply to R-2, R-3.
 - Highway zoned parcels Add verbiage "Any change to the business, i.e. closing, change of ownership, change of business, the Town must be notified so the new business is in compliance with codes and ordinances."
 - o 4.10 A, B, C add "Residential"
 - 4.10 D Add Commercial Wind ordinance
